PLEASE READ CAREFULLY:

GUIDELINES

- A** The Parents/ guardians are requested to go through the terms and conditions thoroughly mentioned in the School Prospectus along with the fees structure and other financial liabilities before taking the admission (subject to qualify). In case of any difficulties / confusion, feel free to contact with the Mid-Office Manager/ Public Relation Officer of the Organization.
- B** The school issued two numbers of forms i.e. Form – A and Form – B.
- C** The Form – A is basically issued for Eligibility test/ Counseling of the students.
- D** The Form – B would be issued (without any cost) after qualifying in the eligibility test/ counseling and *it should be filled up in presence of the School Authority.*
- E** Initial documents to be produced at the time of submission of Form – A before appearing the eligibility test/ counseling, which are as follows:
- Two copies of recent passport size photographs of the candidate.
 - Photostat copies of Birth Certificate of the candidate issued by the Govt./ Municipality/ Panchayat.
 - Photostat copies of two photo Identity Proof of the Parents/ Guardians . [Voter ID / Driving License / Passport/ Aadhar Card / Bank Passbook/ Identity card if Govt. Employee]
 - Confidential forms of the Parent's provided by the school authority should be filled up in detail & submit the same with seal.
 - Photostat copy of progress report/ marksheet of the candidate (other than Playgroup) appeared in the last examination should be submitted with the Form – A.
 - The guardians must have to submit the transfer / school leaving certificate at the time of taking admission, if eligible.
- F** Validity for submission of Form – A is 30 days from the date of issue of the form.
- G** **Required documents to be produced after eligible for taking admission that are as follows for 'Form – B' provided by the School Authority:**
- Recent passport size colour photographs** – (a) 4 copies of candidate (b) 2 copies each of parent (c) 2 copies of authorized local guardian (if applicable) (d) One copy of postcard size joint photograph of father, mother and ward.
 - Blood group report of the candidate to be submitted by the guardian from authorized pathology centre.
 - Medical certificate of the candidate provided by the Guardian by a Regd. Medical Practitioner / Officer.
- H** Parent's (both father and mother) must appear during the counseling an admission (except for any special cases). In case of any special case, the guardian/ parent authorize a local guardian, the concerned person has to be personally present with the parents at the time of admission/ counseling. In that case, the local guardian has to be submitted all of his detail personal documents.
- I** In case of change of the natural guardianship of the ward (candidate) and or change of name of any person (candidate or parent) submit the supporting legal documents issued by the Court of Law.
- J** If any one of the parent remain absent due to any unavoidable circumstances, the admission of the candidate will be provisional and the admission will remain valid for only two (2) months from the date of admission or else admission will be cancelled for not fulfilling the criteria.
- K** Under any circumstances, the necessary fees which have been deposited earlier are not entitled for any refund except for the Caution Deposit.
- L** The eligible candidate should take admission the very day of counseling or else a minimum amount of 10% of the total admission fees have to be deposited towards the confirmation of admission and the rest balance amount must be deposited within the 3 consecutive days. The amount that has already been deposited on the day of counseling is not refundable.
- M** The entire school fees of a session (1st April to 31st March) are applicable only even in case of taking late admission of any candidate, the school will collect the entire fees of the session.
